

Polypropylene feet are pushed in to the bottom of the chair legs and are easily removed for recycling. The 4 leg base also has 2 x silicon extrusions clipped to the underside of the frame for chair stacking purposes – again these are dry fixed and easily removed for recycling. The 4 leg base in screwed to the chair shell with 4 x steel screws.


